- Assistance handling all documentation and phone calls needed to resolve your case.
- 3-in-1 credit report, 1 year of credit monitoring.
- 1 year of fraud monitoring of more than 1000 public records databases.
- Optional credit file freezes where available.
- Assistance for victims of wallet and purse theft.

Identification Document Recovery
